In lieu of Sl. No. 1, 2 & 3 above for **Autonomous Institutions:**

The period of approval to Institutions for the courses and intake (as per EOA and corrigendum (if any) for the Academic Year 2016-17) shall be for a period of **3 years. Institutions are however, required to submit updated Institutional information including faculty and students on the AICTE web portal for downloading Extension of Approval letter every year. Processing fee for EOA will be waived during this period.** However, It may be noted that though extension of approval is granted for 3 years, the Council shall monitor for fulfillment of all norms by the Institute and in the event of non-fulfillment, the Council shall initiate penal action as per regulations and the extended approval will be withdrawn and the institute need to remit the Processing Fee only for EOA as per the Approval Process Handbook for the current Academic Year and subsequent years also.

The above mentioned approval is subject to the condition that SRI KRISHNA COLLEGE OF TECHNOLOGY shall follow and adhere to the Regulations, guidelines and directions issued by AICTE from time to time and the undertaking / affidavit given by the institution along with the application submitted by the institution on portal.

In case of any differences in content in this Computer generated Extension of Approval Letter, the content/information as approved by the Executive Council / General Council as available on the record of AICTE shall be final and binding.
